What was expected of the US "Fed" by its progenitor?

"The few who can understand the [Federal Reserve] system will either be so interested in its profits, or so dependent on its favors, that there will be no opposition from that class, while on the other hand, the great body of the people mentally incapable of comprehending the tremendous advantage that [our] capital derives from the [Federal Reserve] system, will bear its burdens [INFLATION PLUS the predictable and unseen endlessly growing national debt] without complaint, and perhaps without ever suspecting that the system is inimical to their [The People's] interests."

"We are bankrupted. We are insolvent on every level of our national life, whether it is corporate, whether it is just plain you and I out there with the life of debt that we have all piled up, private debt, credit cards and what not, or whether it is the government. We are insolvent. How long will it take before that nasty mega-truth is conveyed?"

The remarks above by Rep. Gonzalez at <http://thomas.loc.gov/cgi-bin/query/z?r102:H04MY2-37>: are utterly damning. This is a story on how it came to be and what lies ahead if we and our government don't come to grips with what's contained within. What you will read here is intended to demonstrate that it's all been "planned" by some of the world's most clever minds using their knowledge and extensive *familial intergenerational* experience of fractional reserve *national* banking.

JFK Speech 1961

In order to properly set the tone for what you will read in this booklet, let's go back in history to an excerpt from a JFK speech shortly after being elected in November 1960.

Known in some circles as the "**Secret Societies Speech**" it's listed on JFK's library site as "**The President and the Press: Address before the American Newspaper Publishers Association**". It was given at the NY Waldorf-Astoria on April 27th, 1961. We're told the speech was directed towards Communism. What wasn't said was far more important than how the meaning of his speech was later *steered*. JFK was referring to that group of **Bolsheviks** that were all Communists at the outbreak of the 1917 Russian Revolution. **Bolsheviks** whose progeny today, **that within their conspiracy**, routinely use debt to undermine nations and their people. JFK knew because his father as the 1st SEC Chair knew.

For we are opposed around the world by a monolithic and ruthless conspiracy that relies primarily on covert means for expanding its sphere of influence—on infiltration instead of invasion, on subversion instead of elections, on intimidation instead of free choice, on guerrillas by night instead of armies by day. It is a system which has conscripted vast human and material resources into the building of a tightly knit, highly efficient machine that combines military, diplomatic, intelligence, economic, scientific and political operations.

Its preparations are concealed, not published. Its mistakes are buried, not headlined. Its dissenters are silenced, not praised. No expenditure is questioned, no rumor is printed, no secret is revealed. It conducts the Cold War, in short, with a war-time discipline no democracy would ever hope or wish to match.

JFK was murdered on November 22, 1963. This was less than 6 months after signing **Executive Order (EO) 11110** in June of the same year. EO 11110 established a *new currency*: the **United States Note** backed with specie; precious metal: Silver. JFK's **non-interest-accruing, debt-free inflation-proof United States Note** would have been in direct competition with the privately owned US Federal Reserve's **debt-creating interest-accruing, inflation-prone Federal Reserve Note**. A Short Digression: *The Italian-American Civil Rights League*

The ***Italian-American Civil Rights League*** was formed as a political group in and around New York City in the early 1970s. Its stated goal was to combat pejorative stereotypes about Italian-Americans. The "League's" primary purpose was to parse "**The Italians**" from those commonly referred to as "**The MAFIA**". While there was a tacit admission that the MAFIA was made up mostly of **Italian Americans**; it brought national attention to the fact that "**The Italians**" certainly were not all members of the **MAFIA**.

The group began as ***The Italian American Anti-Defamation League*** on April 30, 1970. Shortly thereafter on June 28, 1970 the organization held a large rally at **Columbus Circle** NYC. The "League" gained further momentum when Frank Sinatra held a benefit concert in its honor at Madison Square Garden in November of 1970.

The group then turned its attention to what it perceived as cultural slights against Italian-Americans. It used the threat of boycott to force Alka-Seltzer and The Ford Motor Company to withdraw television commercials to which the league objected. The "League" also succeeded in having United States Attorney General John Mitchell order the United States Justice Department to stop using the word "Mafia" in official documents and press releases. The League secured an agreement from Al Ruddy, producer of ***The Godfather***, to omit the terms "Mafia" and "Cosa Nostra" from the film's dialogue. It succeeded in having Macy's stop selling a board game called ***The Godfather Game***.

The "League" was populated by **Italians** of all backgrounds. It was even semi-hosted by members of the **MAFIA**. The goal? Inform the public that ""**The Italians**" were **NOT "The MAFIA"**.

Yes... the MAFIA for the most part was *Italian*, but "**The Italians**" were not *all* MAFIA. A simple premise and there it started; a frustration for the average Italian American family when their children were accused in school. In the 1970's "The Italians" began the process of parsing/separating themselves from a **criminal syndicate** of fellow Italians that were *discretely* galvanized together as... **a criminal syndicate**.

However, once the entire dynamic is understood, a fundamental issue should have been addressed then by "The Italians". "The Italians" **always knew** that there was a MAFIA among them, **but rarely if ever spoke of it**. "The Italians" knew that there was a hierarchy... **and a Chain of Command**. However, it is my opinion, and that of many more that know of these facts, **that by their silence "The Italians" were somewhat guilty for the criminal deeds of the MAFIA's members**.

Almost two generations have passed since those demonstrations at Columbus Circle in NYC. It's now part of "their" history. But history it is and now "The Italians" travel through their lives without the same tarnish once attributed to *all* of them. They continue to make serious and outstanding contributions in virtually every facet of today's society; much the same as "**The Jews**". And yes... there still is an Italian MAFIA; slowly being overtaken by another MAFIA... **of Russians**. (As you'll soon learn, all Jews are Russian, NOT Semitic! As in virtually 100% with very few exceptions.)

Anti-Semitism: The Rest Of The Story...

Here we are in 2013. "**The Jews**" continue to be blamed for virtually anything that goes wrong... **right?** They've been the pariah of virtually every culture, society and epoch down thru centuries of history. WHY? **They know! They really do know!!** No different than "The Italians" of the 1950's. **They knew! The Italians** had a CRIMINAL SYNDICATE within their midst. **They knew** that some in their family may be/were members.

While the Jews of today are not all involved... DIRECTLY, "The Jews" of today **are FULLY aware** of a **criminal syndicate** **OF** fellow Jews that have been operating in the shadows... *not of the streets*, but of **the law firms, financial centers and governments** of the world for centuries. To be sure Jews when confronted by a non-Jew would claim ignorance or would resist the connotation of "**criminal**". Just plain "syndicate", **criminal** in its truest sense of the word (See the 5th paragraph on this page,) or not, the **syndicate** is well known within the Jewish community. This writer/compiler has multiple 1st person experiences of Jewish recognition of *their* "syndicate".

Winston Churchill in the **Illustrated Sunday Herald**, **8th February, 1920** spoke openly about what he knew even then. Then it was known as a "**movement**". From there in the early 1900's it merged with what was already known as Zionism. **Today it IS Zionism:**

*"This **movement** among the Jews is not new. From the days of Spartacus – then Weishaupt, to those of Karl Marx, and down to Trotsky (Bronstein, Russia), Bela Kun (Hungary), Rosa Luxembour (Germany), and Emma Goldman (United States), this world-wide conspiracy for the overthrow of civilization and for the reconstitution [reconstruction] of society on the basis of arrested development, of envious malevolence, and impossible equality, has been steadily growing."*

The criminal syndicate **of** Jews that I (and Sir Winston Churchill,) speak of, is *similar* to the MAFIA, but only in its criminality. This criminal syndicate of Jews is far superior, more brilliant and more cunning as compared to the *Italian* MAFIA. The Italian MAFIA **breaks the law** to accomplish its goals. Rothschild's syndicate of Jews however, rarely if ever breaks the law. Rothschild's MAFIA is well enough organized and compartmentalized within governments and law firms to **CHANGE the law before they break it**; i.e. the repeal of the 1933 Glass-Steagall Act in 1991. The repeal was accomplished by and through the efforts of Robert Rubin and Larry Samuelson, aka Summers. Both these men are "Capos" in the Rothschild MAFIA.

The repeal of Glass-Steagall in 1991 by Messrs.' Rubin and Summers, allegedly for Sandy Weil, then CEO of Citigroup, facilitated **their long planned** Mortgage Meltdown of 2006 forward. Mr. Weil is also a member of the Rothschild MAFIA/syndicate. They all are or have the ability to be dual citizens of the US and **ZIONIST Israel** due to a Rothschild 1950's inspired "**Law of Return**".

The Italian MAFIA uses sheer force as its weapon; muscle, guns, bullets, and **BOMBS**.

Rothschild's Zionist MAFIA uses **Public Law** with pens and **BONDS**; creative and innocuous sounding **BONDS** like **Credit Defaults, Stated** (liars) **Loans** (Mortgages,) and **TIPS; Treasury Inflation Proof Securities**. Not the least of these is commonly known as the **Federal Reserve NOTE**. All created by Rothschild's people within our governments, (Federal and State,) law firms and any financial powerhouse where they can take control; i.e. Lehman Brothers, Goldman Sachs, AIG and Citicorp to name just a few.

Some European families have been making beer, wine, cheese and autos for over, and even for multiple **centuries**. Rothschild and his ARMY of embedded **Zionist soldiers** hidden **within the**

governments of various targeted nations of the world that for centuries have been perfecting newly created/designed **WMD's; BONDS, Weapons of Monetary Destruction**. (See back cover.)

Chain of Command: Is there one and who is in charge?

Rothschild long ago in the 18th century learned that he could take over a nation by creating a war between geographic neighbors. Then, hidden behind *different identities* (see Lysander Spooner page 151,) being the lender of choice for both; and pulling the financing from one side at the appropriate moment would create the winner of his *artificial* conflict. Clever, cunning and very effective this "**King of the Jews**" wouldn't you say? Look around our Congress. Who are the "hawks" towards the middle-east? Predominantly **Jews**, protecting our so-called ally Israel. Then again we're not permitted to draw attention to this FACT. Anti-Semitism is being used as the cloaking device it was designed to be. But take care, while these Congress people may be predominantly Jews they are much more. They are members of **Rothschild's Zionist Army**.

While not all **actively** engaged, the greater majority of Jews do know full well what's happening. Four years later in November of 1917 was the date of the **Balfour Declaration as addressed to a Rothschild** initiating of the creation of **Israel**.

The timing of these events, 1913 *Fed*, 1917 *Russian Revolution* and again in 1917, the *Balfour Declaration* that began the State of **Zionist Israel** is not a coincidence. The dates tell much of the story. However, to push this particular issue of dates over the top we also have WWI.

While Rothschild believed that Russia was ready to fall to his Bolsheviks in 1905, the timing proved premature and the 1905 Russian Revolution failed. Therefore, it appeared to have been determined that the Czar's troops needed a distraction. The Rothschild's knew that a great distraction was on the way: WWI. World War I was a global war centered in Europe and depending on your point of view began on 28 July 1914 or at the trigger point with the assassination of Archduke Ferdinand on June 28th, 1914. PRAVDA to America: *Do Not Give Up Your Guns!*

These days, there are very few things to admire about the socialist, bankrupt and culturally degenerating USA, but at least so far, one thing remains: the right to bear arms and use deadly force to defend one's self and possessions.

This will probably come as a total shock to most of my Western readers, but at one point, Russia was one of the most heavily armed societies on earth. This was, of course, when we were free under the Tsar. Weapons, from swords and spears to pistols, rifles and shotguns were everywhere, common items. People carried them concealed, they carried them holstered. Fighting knives were a prominent part of many traditional types of attire and those little tubes crisscrossing on the costumes of Cossacks and various Caucasian peoples? Well those are bullet holders for rifles.

Various armies, such as the Poles, during the Смыта (Times of Troubles), or Napoleon, or the Germans even as the Tsarist state collapsed under the weight of WW1 and Wall Street monies, found that holding Russian lands was much harder than taking them and taking was no easy walk in the park but a blood bath all its own. In holding, one faced an extremely well-armed and aggressive population Hell bent on exterminating or driving out the aggression

This well-armed population was what allowed the various White factions to rise up, no matter how disorganized politically and militarily they were in 1918 and wage a savage civil war against the **Reds/Bolsheviks/Jews/Zionists**. It should be noted that many of these armies were armed peasants, villagers, farmers and merchants, protecting their own. If it had not been for hidden **Jewish/ZIONIST direction of Washington DC's clandestine support** of and for the **Reds/Bolsheviks/Jews/ZIONISTS**, history would have gone quite differently.

Of course being savages, murderers and liars does not mean being stupid and the **Reds/Bolsheviks/Jews/ZIONISTS** learned from their Civil War experience. One of the first things they did was to disarm their fellow population. From that point, mass repression, mass arrests, mass deportations, mass murder, mass starvation were all a safe game for the powers that were. (See footnote on page 37 and ask yourself which of the 2 federal courts has jurisdiction over you.)

10. Ameriquest created the "Stated (liar's) Loan" & paid \$325 million in fines for predatory lending. Mr. Arnall a dual American/Zionist Israeli citizen, curiously died of *spontaneous* cancer on 3.17.2008. http://TheRealNews.com/t2/index.php?option=com_content&task=view&id=31&Itemid=74&jumival=3708
11. The Credit **Defaults** were traded at "**AIG Financial Products Corp.**" located in the **City of London** (not to be confused with **London City**,) down the street from the banking cartel that instigated the 1913 creation of the privately owned Federal Reserve and the 1917/47 creation of the State of Zionist Israel: the **House of Rothschild**. Due to "Creditor's Rights", Mr. Ben Shalom Bernanke, also a Zionist Israeli Citizen, and the US Federal Reserve has seized "**AIG Financial Products Corp.**" and taken control of any evidence of wrongdoing. *Where's the US Congress?*
12. Records of the above can now be claimed to be lost... *gone*. **Why? The "Towers" could NOT have come down the way we have been led to believe. I was at the "meetings". The WTC fire code has never been discussed. I know that everything installed in the *interior* was specifically **FIREPROOF**; with the exception of executive wood furniture; *eventually* exempted from the WTC fire code but was never installed in enough quantity to have caused a fire with the necessary intensity to weaken steel columns to the point of failure.

⁴ Rothschild's 17th Lecture in Basel Switzerland, 1897, 3rd paragraph: *When the time comes finally to destroy the Papal Court the finger of an invisible hand will point the nations towards this court. When, however, the nations fling themselves upon it, we shall come forward in the guise of its defenders as if to save excessive bloodshed. By this diversion we shall penetrate to its very bowels and be sure we shall never come out again until we have gnawed through the entire strength of this place.*

⁵ Sent to the US in 1901 by Natty Rothschild to get the process started... "*the technical details of the Federal Reserve Act is the work of Mr. [Paul] Warburg more than any other man in the country...*" (See Edwin Seligman, *Proceedings of the Academy of Political Science*, Vol IV, No. 4 (NY). Pp 3-6.) (Mr. Warburg was *Daddy Warbucks* in the "Little Orphan Annie" comics.)

Now for a quick change in topic and era. It's historically provable that in 1901 Natty Rothschild, partner in the privately owned US Fed, (still today?) sent Paul Warburg here to begin the process ("...*technical details*.) of instituting the Fed as a Central bank to the US. A privately owned bank/system, a NATIONAL DEBT generating machine, that the US Congress **never had the lawful authority to create. Power to legally create, but ZERO... Constitutional (lawful) authority.** In other words, the "fed" could be declared a fraud, **albeit a brilliant piece of monetary architecture that should never be "abolished"; imho.** A true "gift". "Our property" they will not touch, because the moment of attack will be known only to us and we shall take measures to protect our own. (Mr. Natty Rothschild lectured and made this threat in 1897. Watch your headlines today.)

(As an aside, butter wouldn't melt in Mr. Netanyahu's mouth during his 5/2011 speech before the US Congress. Purechutzpah (big balls). Mr. Netanyahu believes we're stupid, and rightfully so, Israel is laughing at us. [Read today's headlines. It appears that Rothschild's 1897 threatened "**Political Smash**" is here again in 2013!]

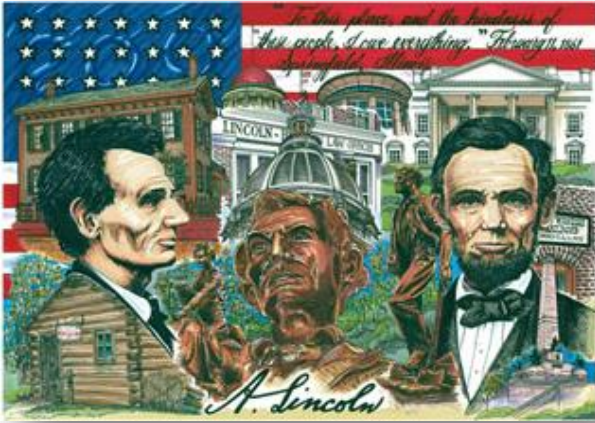

SABROSKY INTERVIEW TIES ISRAEL TO 9/11

US ARMY WAR COLLEGE, FORMER DIRECTOR OF STUDIES DR. ALAN SABROSKY

Meet Dr. Alan Sabrosky, a brave man, a USMC Vietnam vet, an American Jew **and someone devoted to the security of the United States at any cost**. Ask any Jew what it takes to stand up against the most powerful and ruthless group in the world, the Zionist Israeli lobby inside the United States.

Dr. Sabrosky has been calling for a new 9/11 investigation for some time. What makes him unique is that we have a Jew who can hardly be called "self-hating" or "anti-Semitic" or against Israel. He is consistent in everything he says. His point is that you are an American or you are an Israeli but you can't be both, especially now with Zionism turning Israeli foreign policy into a "runaway train." 9/11, as Sabrosky sees it was the watershed in a relationship between America and Israel that has gone from bad to un-survivable, especially for America. He contends that AIPAC exercises near total control over the electoral process in America through the ability to outspend any other group and destroy anyone who stands against them.

The unwillingness of the US to stand with the international community on humanitarian and war crime issues where Israel is found in continual violation is, to Sabrosky, a critical issue. In discussion the US and her lack of support for the Goldstone Report, Sabrosky says:

US criticism of the HRC resolution should be disregarded, as Washington only parrots Israel's wishes here...

... it might have been better to have included Goldstone's condemnation of Hamas offenses as well, but it is legitimate as it stands for five reasons: (1) Israel committed the great majority of the

violations; (2) Israel had an overwhelming preponderance of military power; (3) Palestinians suffered almost all of the death and destruction; (4) Israel has a long, sordid history of ignoring UN commissions and resolutions, and of attacking UN facilities and killing UN staff, as when the clearly marked UNRWA facility in Gaza was bombed; and (5) the HRC focus is properly on the actions of the oppressor (Israel) and not on those of the oppressed (the Palestinians).

Another is that it did not accord Israel the right of self-defense. But Israel's claim to self-defense in its savaging of Gaza is specious, because Israel — like all occupiers and oppressors — has no inherent right of self-defense against its victims. Who, for instance, would have accepted Nazi Germany's assertion that its brutal reprisals against the Czechs for their assassination of a Nazi commander named Reinhard Heydrich was an exercise in self-defense? No one, and no one should accept Israel's claim, either.

A third is that holding Israel accountable for its actions will somehow endanger the Middle East peace process. But there is no peace process, simply meaningless discussions to the dead end (for Palestinians and the rest of the region) of Israeli hegemony, and under Netanyahu or any electable government in Israel, there is not and cannot be one. There will be an enforced peace imposed from outside of the Middle East, over the objections and obstruction of Israel, or there will be none at all.

ZIONISM AND ISRAELI NATIONALISM

This is how Sabrosky describes the nature of Jewish nationalism as described within the term we call **"Zionism"**:

The differences between Jewish nationalism (Zionism) and that of other countries and cultures are fourfold:

- 1. Zionism is a real witches' brew of xenophobia, racism, ultra-nationalism and militarism that places it way outside of a "mere" nationalist context — for example, when I was in Ireland (both parts) I saw no indication whatsoever that the Provisional Irish Republican Army or anyone else pressing for a united Ireland had a shred of design on shoving Protestants into camps or out of the country, although there may well have been a handful who thought that way — and goes far beyond the misery for others professed by the Nazis;*
- 2. Zionism undermines civic loyalty among its adherents in other countries in a way that other nationalist movements (and even ultra-nationalist movements like Nazism) did not — e.g. a large majority of American Jews, including those who are not openly dual citizens, espouse a form of political bigamy called "dual loyalty" (to Israel and the US) that is every bit as dishonest as marital bigamy, attempts to finesse the precedence they give to Israel over the US (lots of Rahm Emanuels out there who served in the Israeli army but NOT in the US armed forces), and has absolutely no parallel in the sense of national or cultural identity espoused by any other definable ethnic or racial group in America — even the Nazi Bund in the US disappeared once Germany and the US went to war, with almost all of its members volunteering for the US armed forces;*
- 3. The "enemy" of normal nationalist movements is the occupying power and perhaps its allies, and once independence is achieved, normal relations with the occupying power are truly the norm, but for Zionism almost everyone out there is an actual or potential enemy, differing only in proximity and placement on its very long list of enemies (which is now America's target list); and*
- 4. Almost all nationalist movements (including the irredentist and secessionist variants) intend to create an independent state from a population in place or to reunite a separated people (like the Sudeten Germans in the 1930s) — it is very rare for it to include the wholesale displacement of another indigenous population, which is far more common of successful colonialist movements as in the US — and perhaps a reason why most Americans wouldn't care too much about what the Israelis are doing to the Palestinians even if they DID know about it, is because that is no different than what Europeans in North America did to the Indians/Native Americans here in a longer and more low-tech fashion.*

Sabrosky is one of the few Americans who see the nuclear threat of Israel as it is, blackmailing the United States, not only in how it could be used to draw America into an unwanted war, but how it could actually be used at some point to attack the United States itself. Only recently, Israel put Western Europe on notice that it would be attacked if its actions threatened Israel, attacked by nuclear weapons from Israel without warning. Martin van Creveld's threat combined with Sabrosky's analysis of Israeli intentions and culpability for 9/11 brings to mind something Sabrosky had once written.

He has always seen Moshe Dyan as a hero. Dyan saw Israel's military role as that of a "junk yard dog," ready to bite without warning, attack anything and anyone. Sabrosky notes that, eventually such an animal is always put down or as he puts it, *"the preferred response of everyone else is to kill that mad dog before it can decide to go berserk and bite."*

9/11

Sabrosky makes a case, not just for a cover-up of 9/11 but goes much further. He points out as do so many that the physics of the attack are unworkable. He, however, is one of the few to point to a conclusion many find obvious but few have the nerve to admit, that it would have been impossible to stage 9/11 without the full resources of both the CIA and MOSSAD and that 9/11 served the interests of both agencies quite well.

There was nothing they could have wished for more.

Sabrosky also makes a point involving media coverage of 9/11:

Finally, we need to take a hard look at why the mainstream media (MSM) have paid more attention to Sarah Palin's wardrobe than they have to dissecting blatant falsehoods, discrepancies and inconsistencies in the US Government's treatment of 9/11 and its aftermath.

ZIONISM AND TREASON

The inescapable point isn't the 60,000 Americans killed or wounded in a war started out of treason or the world it threatens to destroy. Americans have been looking away from these glaring realities the way they looked away from Vietnam. Sabrosky leaves Israel and her American Jewish supporters who he sees as traitors with a warning:

If these Americans and those like them ever fully understand just how much of their suffering — and the suffering we have inflicted on others — is properly laid on the doorsteps of Israel and its advocates in America, they will sweep aside those in politics, the press and the pulpits alike whose lies and disloyalty brought this about and concealed it from them. They may well leave Israel looking like Carthage after the Romans finished with it. It will be Israel's own great fault.

Do we take Sabrosky seriously because he is a Marine or a Jew? Do we wonder why the things he says reach so few? Is America in a shooting war where our biggest enemy sits behind us, killing us off, robbing us blind and whispering gently in our ears how much they love us?

It would seem so.

The **Lavon Affair** refers to a failed Israeli covert operation, code named **Operation Susannah**, conducted in Egypt in the summer of 1954. As part of the false flag operation, a group of Egyptian Jews were recruited by Israeli military intelligence for plans to plant bombs inside Egyptian, American and British-owned targets. The attacks were to be blamed on the **Muslim Brotherhood**, Egyptian Communists, "unspecified malcontents" or "local nationalists" with the aim of creating a climate of sufficient violence and instability to induce the British government to retain its occupying troops in Egypt's Suez Canal zone. The operation caused no casualties, except for those members of the cell who committed suicide after being captured.

The operation ultimately became known as the **Lavon Affair** after the Israeli defense minister Pinhas Lavon was forced to resign as a consequence of the incident. Before Lavon's resignation, the incident had been euphemistically referred to in Israel as the "**Unfortunate Affair**" or "**The Bad Business**" (Hebrew: העסק הביש, HaEsek HaBish). **After Israel publicly denied any involvement in the incident for 51 years, the surviving agents were officially honored in 2005 by being awarded certificates of appreciation by Israeli President Moshe Katzav.**
